5. OLD BUSINESS:

 Mr. Fuentes – Old Dixie Hwy color for a section of sidewalks presentation followed by the BOD selection of color. Project and art updates.

MRTNA BOD members (via proxy and from the floor), and MRT residents/ members presents at the meeting, voted unanimously selecting the FLEXIPAVE CONCRETE ZX as the color of choice for the additional sidewalks. It was also agreed that all Old Dixle Hwy sidewalks must be the same color shade (light grey). A letter from the MRTNA BOD was hand delivered to Mr. Fuentes. The letter indicated the FLEXIPAVE CONCRETE ZX as the MRTNA selected color.

- Mrs. Rivera Kaboom Project updates June 2nd build day:
 Shared Info from Mrs. Rivera email and called for volunteers.
 - Fort Lauderdale Cares Day Grant and dock repairs:

\$ 200 Rotary Club grant – local landscaper and his team of volunteers picked up mulch, laid it and pruned the dock area.

Dock repairs: They are more extensive than we thought. The City is working on a revised cost estimate and will get us the extra money to complete. Still working on a timeline but confirmed we are still moving forward on this earlier this week. In the meantime the area has been cordoned off.

Vacation rentals:

The legislation to remove regulations has passed the early stages but we are still fighting it.

Medical Marijuana:

Medical Marijuana dispensaries: it doesn't appear that will have any in our neighborhood. Those shops could not be within 1.200 feet from schools, churches, daycare centers and another marijuana dispensary.
